Response to Additional Information Request and Notice of Withdrawal of License
Transfer Application**

Dear Acting Secretary Reese:

On July 11, 2024, staff of the Federal Energy Regulatory Commission (Commission or FERC) issued an Additional Information Request in the above-referenced proceedings,¹ requesting Pacific Gas & Electric Company (PG&E) and Pacific Generation, LLC (Pacific Generation) (together, Applicants) to provide an update to the Commission regarding Applicants' plans for the pending Joint Application for Approval of Transfer of Licenses (Transfer Application),² in light of the California Public Utilities Commission's (CPUC) recent denial of a Certificate of Public Convenience and Necessity to Pacific Generation to operate as a utility under the CPUC's jurisdiction.

Due to the CPUC's denial, Applicants are no longer seeking to transfer PG&E's hydropower licenses to Pacific Generation. Accordingly, Applicants, in accordance with Rule 216 of the Commission's Rules of Practice and Procedure,³ hereby withdraw the Transfer Application.
